- ❖ **Express Service** is also available to exporters on additional cost basis. The charges for express service will be twice the charges of the normal cost. The certificate will be issued to the exporters within 7 working days from receipt of completed Form B, Form E and supporting documents.
- ❖ Please note for any **amendment** in the certificates once it has been issued, an exporter has to pay Rs. 500/- (plus applicable 18% GST) per certificate as amendment charges. Further, in case the invoice submitted has been revised (along with contents), the entire Vriksh Shipment certificate has to be amended and it will be treated as a fresh case and a new certificate will be issued for which the same charges will be applicable which are applicable for issuance of new certificate.
- ❖ In case a certificate has been lost and a duplicate certificate is to be issued, the charges for such duplicate certificate will be Rs.1000/- (plus applicable 18% GST), however the content of the certificate would remain same. In case of any amendment in contents of the certificate other than the Species/quantity/weight which does not require re-inspection, an additional charge of Rs.500/- (plus applicable 18% GST) will be levied for such amendments.
